

REVISED NOTICE OF FILING AND PUBLIC HEARING

Annual Review of Purchased Gas Adjustment and Gas Purchasing Policies of Piedmont Natural Gas Company, Incorporated (For Potential Increase or Decrease in Gas Adjustment)

Why is this Notice Important?*

- The Public Service Commission has scheduled a public hearing regarding a review of the purchased gas adjustments and gas purchasing policies of Piedmont Natural Gas Company, Incorporated.
- The Public Service Commission decides what rates a utility can charge.
- This Notice is for natural gas customers of Piedmont Natural Gas Company, Incorporated and interested persons.

What is the purpose of this case?

- Piedmont Natural Gas Company, Incorporated can and does purchase gas from outside businesses to serve its residential, industrial, and commercial customers.
- During the hearing in this case, the Public Service Commission will review the costs that Piedmont Natural Gas Company, Incorporated paid for purchased gas to serve the Company's customers.
- The Public Service Commission will evaluate the way Piedmont Natural Gas Company, Incorporated purchased this gas for its customers, and the Public Service Commission will determine if Piedmont Natural Gas Company, Incorporated's method and administration of purchasing gas for its customers is reasonable and prudent as it may affect your bill.
